## **CONCEPT NOTE:**

India is presently the world's fifth largest economy. The growth trajectories of the country that have evolved and developed over the decades have drawn much attention. Yet, an academic review of India's development experience remains significant both for domestic policy discussions as well as for drawing lessons regarding its wider relevance for other developing countries. Not unexpectedly, different economists emphasise divergent factors to try and explain the performance of the Indian economy. Different facets of this development experience deserve further analysis.

This conference is being organised to take stock of India's development experience. Recognising the enormity of the task at hand, the conference will focus on three broad areas: the persistence effects of history, current outcomes in comparative perspectives and the global context of Indian development. Accordingly, the specific themes on which papers are invited are listed below. We welcome interdisciplinary perspectives.

## **THEMES:**

- **Persistence Effects of Colonial Policies**

Papers could be concerned with the various features of the colonial experience as well as its impact on the contours of India's contemporary development.

- **Sectoral Analysis**

Papers could span either the historical trajectory of one sector or a comparative analysis of two or more sectors in different time periods.

- **Regional Dimensions**

Papers could discuss the development experience of one state or one region in the country. Alternatively they could examine the comparative development experience of two or more states or two or more regions of the country.

- **International Context of India's Development Experience**

Papers could examine the various dimensions of international political economy that both constituted a premise of India's development experience. Additionally, they could discuss the impact of India's development on the emerging contours of the international political economy. Both these explorations could be situated in different historical periods of India's development experience.

- **Socio-Political Implications and Outcomes**

Papers could examine the impacts of social and political factors on India's development experience. Further, they could examine the impact of economic changes on the social, political and cultural dimensions of the development of India.

We also look forward to papers from different disciplines on these themes.
