Ved Jolly Resilience Award for Motivated Scholars 2019-20 For I Year Science Students

Dr. Pratibha Jolly, former Principal, Miranda House, instituted three *Ved Jolly Resilience Awards for Motivated Scholars* in memory of her mother. Awards to II and III Year students have already been given in the last semester.

- 1. There is one merit-cum-need award of Rs. 15,000 for I Year students selected from amongst science Honours Courses, namely, B.Sc. Honours in Botany, Chemistry, Mathematics, Physics, and Zoology.
- 2. To be eligible, students should have at least 75% attendance, vibrant participation in co-curricular/extracurricular activities and a good academic record in each semester.
- 3. Students of I Year will be required to apply in Semester II by 24 January 2020 on the basis of Semester I results.
- 4. Applications in requisite format will have to be duly forwarded by the teacher in charge of the department.
- 5. The awardees will be chosen by a duly constituted Selection Committee consisting of the Principal, Vice Principal, Bursar, two teacher representatives on Governing Body; and senior most amongst the teachers in charge of science departments.
- 6. In subsequent years, preference will be given to the student who was given this award in the earlier year so that she is supported for all three years of study.
- 7. The amount will be disbursed by 17 February 2020 to the selected I Year student.
- 8. The student awardee will be given the *Ved Jolly Resilience Award for Motivated Scholar* Certificate on the Founder's Day of the college, usually celebrated on 07 March.
